I, the Volunteer, understand that my activities may include work that may be hazardous to me, including, but not limited to the following: construction; loading and unloading; travel to and from the worksites; and exposure to lead, asbestos, and mold, which may cause or worsen certain illnesses, especially if I do not wear protective equipment, am exposed for extended periods of time, or have a pre-existing immune system deficiency. I, the Volunteer, understand and acknowledge that by this release I knowingly assume the risk of injury, harm and loss associated with the activities. I release the released parties from all liability for harm and loss cost, expense, injury, illness, death, or property damage resulting directly or indirectly for the activities. Photo Release: Volunteer does hereby grant and convey unto Habitat all rights, titles, and interest in any and all photographic images and video or audio recordings made by Habitat during the volunteer's activities with Habitat, including, but not limited to any royalties, proceeds, or other benefits derived from such photographs or recordings.
